Electronic bids must be bought with in **2080/12/16 (March 29, 2024)** and can be submitted to at Bardagoriya Rural Municipality Office, Muda Kailali through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on **2080/12/16 (March 29, 2024)**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on **2080/12/16 (March 29, 2024)**. at the office of Bardagoriya Rural Municipality Office, Kailali. Bids must be valid for a period of 75 (Seventy Five) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to minimum of **NRs. 25,000/- (Twenty Five Thousand only)** which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
