A complete set of Bidding Documents may be purchased from the office **Bardagoriya Rural Municipality** by eligible bidders, till **17:00 on 2075-02-07** on the submission of a written application along with the copy of company/firm registration, vat clearance certificate upto Fiscal year 2074/075 and upon payment of a non refundable fee of amount as mentioned above.
5. Sealed bids must be submitted to the office **Bardagoriya Rural Municipality, Bardagoriya-02, Kailali** by hand or courier on or before **12:00 Hrs** on **2075/02/08/**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of bidders' representatives who choose to attend at **14:00 Hrs on 2075/02/08** at the office of **Bardagoriya Rural Municipality, Bardagoriya-02, Kailali**. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in amounting to a minimum amount specified above, which shall be valid for **75 days** beyond the validity period of the bid (i.e. **2075/04/10**).
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Other mandatory information shall be as per Public Procurement Act 2063 and "Public Procurement Regulation 2064 and their amendments.
9. Any amendments on bidding documents shall be published on office notice board
10. If the bidder, wish to modify or withdraw their bids the bidder should submit sealed application **24hrs** prior to the last date of the bid submission. The bid bond will be forfeited if the bidder wish to modify or withdraw the bid after the above mentioned period.
11. The bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
12. The Employer reserves the right to accept or reject, wholly or partially any or all the bids without assigning any reasons, whatsoever.
